For the post of *Member of the Consumer Grievance Redressal Forum at Bhandup Urban Zone* on Contract Basis.

**1. Pre-requisites & other Conditions:**

1. Candidate shall be representative of a registered Voluntary Consumer Protection Organisation of the area, working preferably for at least five (5) years on matters concerning consumer grievances.
2. Candidate shall be well conversant with Marathi language.
3. Candidate shall be recommended by registered Voluntary Consumer Protection Organisation/registered NGO's in the area working on the matters concerning consumer grievances or Chairperson CGRF.
4. Candidate who have Graduated (in any discipline) from recognised university may be given preference.

**2. Age limit:**

Candidate should not be less than 45 years and more than 64 years of age.

**3. Period of Contract:**

Member of the Forum shall hold office for a fixed term of three years provided that the tenure of a member may be extended for a period not exceeding two years subject to an overall age limit of sixty seven (67) years.

**4. Remuneration & Perquisites:**

Lumpsum monthly remuneration of Rs.20,000/- (Rupees Twenty Thousand only) will be paid. Statutory Taxes will be deducted at source. This remuneration shall be inclusive of allowance such as sitting fees, honorarium and all other allowance such as conveyance allowance, telephone charges etc.

## 6. Selection Process:

- a) The received applications will be scrutinized and forwarded to Maharashtra Electricity Regulatory Commission for nomination.
- b) If necessary, selection process may be on basis of interview to be conducted by Maharashtra Electricity Regulatory Commission/MERC nominee.
- c) Prescribed qualifications are minimum and mere possession of the same does not entitle the candidate for selection.
- d) Canvassing in any form will disqualify a candidate.
- e) If any false/incorrect information furnished by the candidate is detected at any stage of recruitment process, his/her candidature will not be considered.
- f) If the candidate knowingly or wilfully furnishes incorrect or false particulars or suppresses material information, he/she will be disqualified and if appointed, shall be liable for dismissal without any notice or assigning any reasons whatsoever.
- g) The decision of the Company in all matters relating to recruitment shall be final and no individual correspondence will be entertained.
