**1. Pre-requisites & other Conditions:**

**Qualification:** Degree in Law of Recognized University.

**Experience:** Minimum 7 (Seven) year's experience in a position of District Judge.

## **5. SelectionProcess:**

- 5.1 Prescribed qualifications are minimum and mere possession of the same does not entitle the candidate to be called for interview. The candidates will be short listed commensurate with the number of vacancies.
- 5.2 The details of interview schedule will be communicated to the short listed candidates by e-mail, telephonically. The call letter for personal interview will not be sent.
- 5.3 The list of applicants short listed for selection process will be made available on the website of the Company.
- 5.4 The short listed candidates will have to appear for the Personal Interview at their own cost which will be conducted at Mumbai. Traveling expenses will not be reimbursed.
- 5.5 The recruitment in MSEDCL is done strictly as per merit in a systematic way.
