Sir,

1. As you are aware, **Central Institute for Rural Electrification** of Rural Electrification Corporation Ltd located at Hyderabad is organizing training programmes of various natures at different locations.

2. Since CIRE is Nodal Agency for National Training Programs for Franchisees and C&D Employees, bilateral / tripartite MOUs have been entered with the Power Utilities for imparting training to 40,000 Franchisees and 75000 C&D Employees.

3. However, constant request are being received from power utilities, which do not have resource persons, for organizing training programs at various locations by CIRE faculty.
