COMMERCIAL CIRCULAR No. 298

(Amendment to Commercial Circular No.224)

Sub:- Maharashtra Electricity Regulatory Commission (Standards of Performance of Distribution Licensees, Period for Giving Supply and Determination of Compensation) Regulations, 2014 -Implementation thereof

In exercise of the powers conferred under the Electricity Act,2003,the Maharashtra Electricity Regulatory Commission vide notification dated 19.09.2017 has amended the proviso of Regulation 5.3(a) (ii) of Maharashtra Electricity Regulatory Commission (Standards of Performance of Distribution Licensees, Period for Giving Supply and Determination of Compensation) Regulations, 2014 effective from dt.19.09.2017.

Previously, installation on LT side at 400/415 Voltage level in all area other than Municipal Corporation was up to 100 kVA whereas in Municipal corporation Area it was up to 187 kVA. For Multiple consumers at Single Point Supply in Municipal Corporation the installation was above 187 kVA & up to 600 kVA.

Now, the MERC has amended the installation at 400/415 Voltage as shown in amended clause. In view of above amendment to the classification of installations of ac system for Four/Three wires, three phase, the Commercial Circular No.224 dated 05.07.2014 is amended as below:-

	Provided that in case of multiple consumers with contract demand more than 150kW/187kVA,in same building / premises as a single point supply in the Municipal Corporation areas where such limit would be 480 kW/600 kVA	Provided that in case of multiple consumers in the same building /premises with cumulative contract demand exceeding 150kW/187kVA, such limit would be 480kW/600kVA

All other terms and conditions of Commercial Circular No.224 dtd.05.07.2014 will remain unchanged. All the field officers are requested to take necessary action accordingly.
