Recovery of Centages for DDF Scheme Works Sub:

1) Board Resolution No.705 Dtd. 23/06/2016 Ref:

The work of Shifting of DTC, HT line, LT line and such other infrastructure works is carried out under DDF. The applicant either pays 100% estimated cost (called 100% DDF) and MSEDCL carries out the work by full turnkey basis by tenderization OR applicant pays supervision charges (called DDF 1.3% supervision) and after getting permission from MSEDCL applicant carries out the work through licensed electrical Contractor (LEC). The guidelines for the normative charges under DDF 1.3% supervision were issued vide Circular No. CE(Dist)/DIII/MERC/SOC/39938, Dt. 03/11/2007.

In order to have uniformity in loading of centages for DDF works estimates and clarity about recovery of amount thereof from DDF applicant, the following guidelines are approved vide Board Resolution No.705 Dtd. 23/06/2016.

## 1) For DDF Scheme 1.3% Supervision, where applicant has made 1.3% supervision Charges to MSEDCL executed the works through Licensed Electrical **Contrator:**

## Note:

- 1) In this circular, Service Tax is considered @14.5% and MVAT @5.0% while arriving at the amount to be recovered. The corresponding changes in the taxes & duties if applicable shall be incorporated by concerned authorities at the time of actual execution of work and difference in amount if any shall be recovered from DDF applicant.
- 2) The additional expenditure incurred while executing the works, the difference in amount paid and actual expenditure in addition to supervision charges shall be recovered from applicant.
- 3) Latest Cost data & centages of Infra scheme shall be taken for preparation of DDF DPR/ Tender Estimates.
- 4) The consent from applicant shall be taken for payment of difference in amount after final billing & previously paid amount.

This circular comes into force from immediate effect.
