Further to the above, it is informed that the repaired Transformer stocks are not increasing as has been mandated/decided and committed during the Video Conference dt. 4th October 2016. Also, the failure is quite high which is also resulting in absolutely low stock level.

It may please be noted that the actual agricultural Rabbi season load is yet to pick up (because of delayed rains) This increase in agricultural load is likely to result in failures of Transformers unless all out efforts are made to ensure that only sanctioned loads are supplied with electricity. The stock position as on 15.10.2016 is enclosed herewith. The situation is quite serious specially in Latur, Nasik, Jalgaon and Akola zones where the expected repaired Transformers have not been received. The Regional Directors are once again informed that there will be zero tolerance with regards to any delay in replacement of failed Transformers during the Rabbi season.

Head Office is monitoring this on daily basis and Regional Directors are expected to comply with the commitments given on 4th October 2016. It may please be noted that Regional Directors or Zones should not issue any new Transformer to replace the failed transformer and the same shall be released only by Head Office. All the requirements for replacements shall be catered through repaired Transformers only.
