COMMERCIAL CIRCULAR No. 214

Subject: Increase in Time of Day (ToD) rebate for off-peak consumption.
- Continuing for further period from 1 October, 2013 till the issuance of new Tariff Order.



The Commission vide Order dt. 26/12/2012 has approved the increase in the ToD rebate for off-peak consumption (i.e. 2200 hours to 0600 hours) to all such consumer categories for which ToD rebate was approved in Order in Case No. 19 of 2012, from 100 paise/kWh to 250 paise/kWh. This increased ToD rebate of 250 paise/kWh for off-peak consumption (i.e. 2200 hours to 0600 hours) was on only trial basis for 3 months starting from 1st January, 2013. This revised rebate was in force from 1st January 2013 and remained effective till 31st March, 2013.

Further the Commission permitted MSEDCL to continue the enhanced TOD rebate of 250 paise for a further period of six months i. e. up to September 2013. Said decision was communicated to field offices for implementation vide Commercial Circular under reference "5".

Thereafter, MSEDCL has filed Petition seeking extension of applicability of Time of Day (ToD) rebate of Rs.2.50/kWh for off-peak consumption beyond September 2013. Accordingly the Commission vide Order dt. 07/10/2013 has ***extended the applicability of MERC Order in Case No. 42 of 2013 granting ToD rebate of Rs.2.50/kWh for off-peak consumption (i.e. 2200 hours to 0600 hours) by further period from 1 October, 2013 till the issuance of new Tariff Order.***

All field officers are requested to take due note of continuation of increased ToD rebate for off-peak consumption for further period from 1 October, 2013 till the issuance of new Tariff Order.
