Earlier it was mandatory to take NOC from DCC Bank before granting bill collection work to any other agency as per old Agreement [Clause No.8 (ii)], The same has been replaced in the existing agreement and accordingly MSEDCL will have the liberty to assign the work of energy bill collection to any other agencies in the area covered by Municipal Corporation and by 'A' & 'B' Class Municipal Councils. However, in case of area covered under 'C' Class Municipal Council or Gram Panchayat, before allowing the work of energy bill collection to other agency, MSEDCL will inform this to concerned District Bank.

The M.D. Mahavitaran desires to have the information of such agencies to whom the permission is given to collect the energy bill in the areas covered by DCC banks for the month of March 2009. The information of other such Agencies shall be given in the following format.
