Sub: Additional FAC charges to be levied in the billing month of June 2012.

MERC vide above referred order has directed MSEDCL to recover the un-recovered FAC amount of Rs 1483 Crs in 6 monthly instalment, total monthly recovery amount will be Rs 247 Crs (in each month) from Jun 2012 to November 2012. The additional amount of Rs 247 Crs per month will be recovered proportionate to the tariff charged to the Consumer as per their respective category and slab in conformity with the principles specified in Regulation 82.10 of Maharashtra Electricity Regulatory Commission (Terms and Condition of Tariff) (Amendment) Regulations, 2011.

Accordingly, the category wise and slab wise Additional FAC amount has been indicated at Annexure "A" which is to be billed in addition to FAC charges informed vide Circular No. 161 dt. 11/06/2012 in the month of June 2012.
