CIRCULAR No. 135

Sub: Installation of Energy meters and applying Industrial Tariff to account the auxiliary consumption of EHV & MSEDCL Sub Stations.

MSETCL delivers energy from its EHV sub stations through distribution feeders to MSEDCL and total energy is billed to MSEDCL. However EHV sub stations utilize a part of energy delivered to MSEDCL for their auxiliary consumption; & therefore it utmost essential that same is accounted by installing energy meters and the recorded energy should be billed to the concerned, incharge of the s/stn.

Similarly at some places there is un-metered auxiliary consumption used for sub stations and colonies at MSEDCL Sub Stations. Same is also required to be billed, separately.

Hence all the field officers are requested to install energy meters at EHV Sub Station and at MSEDCL Sub Station to record the auxiliary consumptions. The recorded consumptions should be accounted and reflected through IT System for energy accounting & billing purpose.

The recorded consumption for all points of auxiliary consumption at EHV & MSEDCL sub stations shall be billed as per Industrial tariff.

However, it should be noted that, the levy of the tariff will be w.e.f. 01.04.2010 even if it means refund in some cases due to applicability of Commercial tariff.

It should also be noted that payment of bill should recovered in cash/cheque No IBA will be accepted for payment of electricity bill from MSETCL.
