In accordance with the amendment of Regulation 82 of MERC (Terms & Conditions of Tariff) 2005, the FAC will be calculated on pro-rata basis. The monthly FAC charges of particular category/sub category/consumption slab shall not exceed 10% of the variable component of the tariff category/sub category/consumption slab or such other ceiling as may be stipulated by the Commission from time to time.

In this regards, the category wise and slab wise FAC calculated as per amended Regulation & duly approved by Competent Authority for the month of February 2011 to be charged in the billing month of May 2011 are as per Annexure "A".
