COMMERCIAL CIRCULAR No. 208

Subject: New Tariff Category "HT X - Ports" applicable w.e.f. 1st August 2012.

The Maharashtra Electricity Regulatory Commission has determined the Tariff for FY 2012-13 vide Tariff Order dated 16th August 2012 for MSEDCL in Case No. 19 of 2012. Accordingly, the guidelines are issued for implementation of said order vide Commercial Circular No. 175 dt. 05/09/2012. Aggrieved by the tariff categorization of Ports in the said order, Nhava Sheva International Container Terminal Pvt. Ltd., Gateway Terminals India Pvt. Ltd., Indian Private Ports & Terminals Association and Jawaharlal Nehru Port Trust challenged the MERC Order dt. 16/08/2012 before the Hon'ble Appellate Tribunal for Electricity (ATE).

Hon'ble Appellate Tribunal for Electricity vide it's Judgment dt. 19/12/2012 remanded the matter to MERC to consider the issue of the categorization of Ports.

Accordingly Maharashtra Electricity Regulatory Commission vide Order dt. 16/08/2013 in the Case No. 136 of 2012 creates new Tariff category for the Ports as under:

HT X: HT – Ports

Applicability:

This Tariff is applicable for power supply to Ports only.

Rate Schedule:

Consumer Category	Demand Charge (Rs./ kVA/ month)	Energy Charge (Rs./kWh)
HT X: Ports	190.00	9.78
ToD Tariffs (in addition to above base Tariffs) (in paise/kWh)		

The ToD tariff will be applicable based on the Commission's Order dated 26 December 2012 in Case No. 107 of 2012 read with Order dated 2 April, 2013 in Miscellaneous Application No. 42 of 2013 in Case No. 107 of 2012 in Case No. 19 of 2012 and accordingly directives issued vide Commercial Circular No. 175 dt. 05/09/2012, Commercial Circular No. 183 dt. 04/01/2013 and Commercial Circular No. 192 dt. 01/04/2013.

The above tariff is applicable to Ports from 1st August 2012. The excess recovered amount to be refunded to concern Ports.

All Field Officers are requested to take due note of newly created HT X: HT – Ports tariff Category.
