Considering the difficulties of the consumers, the Competent Authority has extended the last date for submission of the Certificate (HT I category – Continuous or Non-continuous) upto 31st August 2007.

It will be necessary for all the consumers to submit the Certificate within the extended date, i.e. 31st August 2007 for getting the benefit of continuous industries for the period from 1st October 2006 to 30th April 2007, failing which the provisions of Circular No. 52 dated 07.05.2007 followed by Corrigendum No. 55 dated 20th June 2007 will be implemented

All other terms and conditions of Commercial Circular No. 52 dated 07.05.2007 will remain unchanged.
