**COMMERCIAL CIRCULAR No. 79**

**Subject:** Exemption from payment of Security Deposit to the employees of MSETCL/ MAHAGENCO for availing single phase residential / commercial connections.

The employees of erstwhile MSEB used to avail the facility of exemption from payment of Security Deposit while availing single phase residential / commercial connections.

Previously, such Security Deposit was not recovered from the erstwhile MSEB's employees as the security of each employee of MSEB, in the form of CPF/ gratuity or any other contribution due; was available with MSEB. Now, the MSEB is bifurcated into four companies with their independent status & independent accounting procedure.

As per clause No.11 of the Maharashtra Electricity Regulatory Commission (Electricity supply code & other conditions of supply) Regulation 2005, the distribution Licensee is entitled to recover Security Deposit from a person to whom electricity supply is sanctioned/ released; & this amount of Security Deposit is equivalent of the average of three months of billing or the billing cycle period; whichever is less.

Now number of employees of MSETCL/ MAHAGENCO are coming for new single phase residential / commercial connections & are requesting for giving exemption for Security Deposit.

In view of above, it is decided that, since security in any form, of the employees of MSETCL & MAHAGENCO is not available with the MSEDCL, the facility of exemption from payment of security deposit to MSETCL / MAHAGENCO employees, should not be allowed further.

All field officers are requested to collect Security Deposit as per rules from employees of MSETCL & MAHAGENCO at the time of giving new Residential/Commercial connection and recover the security deposit from old/existing employees of MSETCL and MAHAGENCO having residential/ commercial connections.
