### Commercial Circular No. 304

**Sub:** "AMNESTY SCHEME - 2018" for Permanently Disconnected HT/LT Industrial Consumers.

**Ref:** 1) GoM letter dated 24.04.2018  
2) Board Resolution No. 1291 dated 05.05.2018

Considering MSEDCL's financial position & consumer's demand of reconnecting the electricity supply, by allowing payment of principal arrears, the Board decided to introduce an **AMNESTY SCHEME-2018** for permanently disconnected HT/LT Industrial Consumers. This scheme is to motivate these consumers to clear their outstanding dues and enable MSEDCL to recover arrears.


The Salient features of the said scheme are as follows:

- 1) An industrial consumer which is permanently disconnected on or before 31.12.2017 is eligible to participate in the scheme.
- 2) The applicant who has purchase property of PD Industrial consumer through Court/ DRT/Liquidators/ Judicial/ Statutory Authorities/ SARFAESI Act 2002 is eligible for this scheme.
- 3) If consumer pays entire principal amount, after adjustment of SD,
  - a) 100% interest (up to date till final payment) to be waived off if consumer pays within One month from the date of starting the scheme.
  - b) 75% interest (up to date till final payment) to be waived off if consumer pays after One month but before three month from the date of starting the scheme.
- 4) 100% DPC to be waived off.
- 5) Date of TD is to be treated as date of PD and Demand Charges after the TD are to be waived off.
- 6) **Decree pass cases:**
  - a) All time barred decreed cases (period above 12 years and where execution petition is not filed) are covered in the scheme. In such cases decreed amount to be recovered in one stroke & interest accrued thereon will be waived off. However the entire litigation cost

will be recoverable from judgment debtor/any person claiming through or on behalf of him.

- b) All executable decrees within a period of 12 years are also be considered under the scheme. In such cases decreed amount to be recovered in one stroke & 50% interest to be waived off. However entire litigation cost is also recoverable.
- 7) Connection is to be reconnected as per MSEDCL rules & regulations.
- 8) The scheme will be implemented w.e.f. 01st June 2018 which will be valid for Three months.
- 9) PD industrial consumers willing to participate in scheme can get the details of amount payable under scheme duly calculated by IT from MSEDCL web site. The link will blink as "AMNSETY SCHEME 2018" on MSEDCL's website.
- 10) The amount paid by consumers under above scheme will be accepted under receipt type '30' so the amount collected under scheme can be monitored separately.
- 11) The consumer can make the payment of bill through net payment/cash payment/cheque payment. (If amount is paid by cheque payment then the date of realization will be treated as date of payment).
- 12) All field offices are instructed to issue bills to a consumer which is served by IT section.

All the concerned field officers are requested to take due note of the above provisions of the **AMNESTY SCHEME-2018** and should make all efforts to achieve maximum recovery of arrears from the consumers whose power supply has been permanently disconnected. Due publicity should also be given to the **AMNESTY SCHEME-2018**, in the local media.
