Sub: Timelines for SEM approvals for Open Access.

Ref: 1) T.O.L. No. CE/Comm/OA/SEM/31645 dated 18.10.2016 2) T.O.L. No. CE/Comm/OA/SEM/34988 dated 24.11.2016

The procedure regarding approval and installation of SEM metering in respect of open access consumers were issued vide letter under ref (1) and the formats of Joint Inspection report to be submitted are issued to all SE (O&M) and all SE (TQA) for reference vide this office letter under ref (2).

In respect of SEM metering installation, the relevant provisions of MERC (Distribution Open Access) Regulations are as under:

17. Metering and Communication

17.1. All Open Access Consumers and Generating Stations shall install Special Energy Meters ('SEM's):

17.4. The Distribution Licensee shall test and install such SEM within sixty days from the receipt of a request from the Consumer or Generating Station, as the case may be.

So, in order to adhere to the time period of sixty days provided in above-mentioned regulations for installation of SEM metering, the stepwise timelines are prepared as under:

5)	Technical Estimate sanction by Circle Office Factory Inspection of CTs and PTs upon receipt of request Testing of Meters upon payment of Testing fees and submission of meter in TQA/NABL lab	10

Note: The above-mentioned timelines are in respect of procedures to be carried out by MSEDCL offices only. The time period for procurement of SEM metering equipment by the open access applicants, other department clearances, etc. are not included in above timelines
