**Appointment of Turnkey Contractors for execution of the works under Agricultural Pumps Energisation Project**

Maharashtra State Electricity Distribution Co. Ltd. (MSEDCL) is a company registered under The Companies Act, 1956 and entrusted with the function of undertaking power distribution in the State of Maharashtra. The Company has prepared a project for construction of associated system for energisation of Agricultural Pumps for the Nagpur Rural Circle of this state, for undertaking proactive network planning to provide power supply to Rural / Urban Ag consumers, reduction of T&D losses and system strengthening. In this scheme, MSEDCL intends to implement the work as detailed below (estimated) under the abovesaid project for implementation during the period 2010 to 2011. The approximate size of the bid which is being awarded by MSEDCL would be Rs. **70.00 Lakhs**. The aforesaid scheme will have to be funded by financing agencies. The work is proposed to be executed on "Turnkey Basis". The time frame for implementation is proposed to be **up to 31.03.2011** from the dates of issue of "**Letters of Award**" to the Turnkey Contractors.

The brief scope of work Sub-Division wise for the "Turnkey" Contractors is outlined below:

- Supply, test, transport, construction, erection, testing and commissioning of HT/LT lines, Distribution Transformer Centers (DTC), DTC metering, Agricultural Pumps Energisation and other allied works as defined in the bid document. **Sale of the Tenders:** Entire bidding document consisting of Volume-I, to Volume-V is available from **24<sup>th</sup> August 2010** onwards in electronic format and is to be downloaded from Employer's website [www.mahadiscom.in](http://www.mahadiscom.in) and Hard copy of Tender document will not be provided from Nagpur Rural Circle office, Nagpur. Any changes in the Tender Schedule, corrigendum etc. shall also be put up in the website only. Prospective bidders are, therefore, requested to regularly check the website for any updates.

**Last date of Uploading** of duly filled Tenders will be **3<sup>rd</sup> September 2010 by 15.00 Hrs.**

**Opening of the Technical Bid on 3<sup>rd</sup> September 2010 at 16.00 Hrs (if possible).**

**Opening of the Price Bid (Soft Copy)** to be notified later to the technically responsive bidders.

**Tender Fee of Rs.6,000/- (Rupees Six Thousands Only) Plus 4% MVAT extra** per Bid may be paid in the form of Demand Draft. Any Bid uploaded without attachment of scanned receipt of demand draft shall be considered as non-responsive and shall be rejected. **Bid Security** - 1% of the Bid Value as mentioned in the above table to be paid in the form of demand draft payable at Nagpur or an unconditional bank guarantee from any nationalised / Commercial / scheduled bank issued in favour of **The Superintending Engineer, Nagpur Rural Circle, Maharashtra State Electricity Distribution Company Ltd, Nagpur** as stated in the bid document. The scanned copy of DD or Bank guaranty shall be uploaded along with the technical bid & original copy of DD or B.G. shall be submitted to the office of the employer before deadline of uploading of tender.

**Contract Performance Guarantee** - The successful bidder has to furnish contract performance guarantee equivalent to 10% of contract value.

**Submission of Tender / Bid** : - Duly completed offers shall be uploaded on employer's website [www.mahadiscom.in](http://www.mahadiscom.in) on or before the due date and time of uploading. MSEDCL shall not be responsible for any delay and tenders received after the due date and time will not be considered. Offers without bid security will be rejected.

**Validity of Offers** - The offer shall be kept valid for a period of 90 days from the last date of uploading of bid. Interested Parties, satisfying the eligibility criteria mentioned below, are requested to upload their offers on percentage basis (below, above or at par of the Tender value) as per the procedures stipulated in the bidding documents.

**Eligibility Criteria** : Bidding is open to Joint Ventures as specified in tender document & all bidders consisting of a single firm who satisfy the qualification criteria set forth in the bidding documents with respect to their experience and financial capabilities. The Contracts shall be awarded to Contractors with relevant experience and required financial strength. The interested party should be a single firm meeting and possessing the eligibility criteria as outlined below:

- At least three years experience as a Prime Contractor in the Construction of Works of similar nature and complexity / Ag. Pump Energisation work on Turnkey basis that required under this contract.
- Cumulative Turnover of the last three years to be **equivalent** of the Bid Value.
- Should have executed single order of a value equivalent to at least **20%** of the estimated cost of the Bid or two orders of **25%** of the estimated cost of the Bid or three orders of atleast **30%** of the estimated cost of the Bid, in any sector during the last Three years. ( 2007-08, 2008-09& 2009-10)
- Prior experience in executing the single order of similar nature of work in Distribution sector with a minimum value equivalent to at least **20%** of the estimated cost of works.
- Should have documentary evidence describing availability of financial resources to exclusively cover cash flow requirements of not less than **25 %** (twenty five percent) of the estimated cost of the works.
- Should have valid Electrical Contractor's Licence;
- Bidder can upload offers for more than one Bid provided, adequate documentation in line with the stipulations of the bidding documents is provided to establish eligibility in terms of financial capability and specific experience in the form of percentages mentioned above but considering the total estimated cost of the number of Bids quoted for. The specific experience in this case would be necessary in executing number of orders equivalent to number of Bids quoted for.
- The bidder should have a cumulative turnover during the last three financial years (i.e., FY 2007-08, 2008-09& 2009-10) which is at least equivalent to the Estimated Cost of the Works.

MSEDCL, in this regard, invites from *interested qualified parties* like manufacturers/ constructors, contractors, etc. of repute for participation in the process for appointing the "Turnkey" Contractors.
