Qualification Requirements:

- **Qualifying Requirements(QR) for Internet Service Provider(ISP)**

- Bidder should be a National Long Distance Service Provider or IP VPN service provider/Basic Service Operator having own Point to Point & Internet leased line network under license from Gol. This License should be valid during the contract period.

- Bidder should have ***Supplied, Installed, Integrated, Tested and Commissioned Point to Point and Internet Leased Lines during preceding five financial years(i.e between 1st Apr 2014 to 31st Mar 2019) fulfilling either any one of the following criteria:***

- One work order/contract(denotes executed only) equivalent to atleast Rs. 44.14 Lakhs.
- Two work order/contract(denotes executed only) together equivalent to atleast Rs. 55.17 Lakhs
- Three work order/contract(denotes executed only) together equivalent to atleast Rs. 66.21 Lakhs in any sector.

- Bidder should have cumulative turnover of atleast Rs.60 Crore for the last three audited financial years.

- Bidder must be registered for GST.

- Bidder except in case of Govt. Organizations/PSU's should have a positive net worth & should be profitable at least once in any of the last three audited financial years.

- The bidder should have implemented at least 3 multi-location WAN Projects (installation, integration, maintenance & management) during the last three financial years out of which at least two projects should have involved Leased Lines (Point to Point & Internet) or ISDN or DSL or VPN/MPLS or Fiber Optics or a combination of these technologies for a customer having a minimum of 50 WAN locations.

- The Bidder should have prior experience in executing at least 1 Project of providing any of the following connectivity Services to State/Central Government Departments or PSU's.

- MPLS Connectivity Services
- Data Connectivity Services
- Internet Connectivity Services
- Point to Point Connectivity Services
