Ltd., payable at Mumbai as mentioned in details in Tender Document (RFP).

## Qualifying Requirements:

- a) The Bidder should have been in operation in India for minimum of five years. And b)
   Bidder should have office in Maharashtra or establish office in Maharashtra if contract is awarded.
- ii. The Bidder, Should have average annual turnover of minimum 10 Cr in the last 3 financial year 2016-17,2017-18 and 2018-19 from the IT Network, Server and Security Infrastructure (Supply, installation and maintenance)
- iii. The Bidder should have a positive net worth during last three audited financial years. The Bidder should have executed either: 1)One work order/Contract costing not less than Rs. 1.30 Crores. Or 2)Two Work Orders/Contracts costing not less than Rs. 75 Lakh each . or 3)Three Work Orders/Contracts t costing not less than Rs. 50 Lakh each . of similar works in IT Network and Security Infrastructure (Supply ,installation and maintenance). Work orders in the last 5 financial years will be considered .
- iv. The Bidder must be authorized by the proposed OEM Solution Provider in India.
- v. The Bidder must have strength of at least 5 OEM certified network engineers on their payroll as on date of submission of this bid.
- vi. The Bidder should not have been blacklisted by any Private/PSU/Central Govt/State Govt. or any other Organization or agencies in India at the time of submission of the bid.
- vii. The Bidder must possess a valid ISO 9001:2015 or latest Certificate
