The Chief General Manager (IT), on behalf of Maharashtra State Electricity Distribution Company Limited (the Employer), hereby invites online bids from eligible bidders for tender of "Comprehensive Annual Maintenance Contract of 2 nos. of 160KVA UPS (including replacement of capacitors) and 2 nos. of 15 KVA UPS at Data Centre, Mumbai and 15 KVA UPS at Server-room, Prakashgad, Mumbai for 1 year".

Tender Fee: Rs. 2,950/- (incl. 18% GST) via ONLINE PAYMENT ONLY (Non-Refundable)

Bid Security: The bid must be accompanied with Bid Security for an amount equal to Indian *Rs.33,100 (Rupees Thirty Three Thousand and one hundred)* for covering the entire scope of work. The bid security shall be denominated in Indian Rupees only. The bid security can be paid online on eTendering portal or can be in the form of a Demand Draft or an Unconditional Bank Guarantee from any Nationalized / Scheduled Bank in favour of the Maharashtra State Electricity Distribution Co. Ltd., payable at Mumbai as mentioned in details in Tender Document (RFP). The BG/DD EMD (original copy) should be submitted to this office on or before submission date and time.

SCOPE OF WORK

MSEDCL desires to appoint a vendor for following UPS activities,

- 1) Comprehensive AMC of 2 nos. of 160 KVA UPS at Data Centre, Mumbai and
- 2) Replacement of Capacitors of 2 nos. of 160 KVA UPS at Data Centre, Mumbai and
- 3) Comprehensive AMC of 2 nos. of 15 KVA UPS at Data Centre, Mumbai and
- 4) Comprehensive AMC of 1 nos. of 15 KVA UPS at Server-room, Prakashgad, Mumbai for a period of 1 year.

Qualifying Requirements:

1. The bidder should be a Company registered in India under the Companies Act 1956/ 2013 or a partnership registered under the Indian Partnership Act 1932 with their registered office in India or a proprietor licensed in India. The Bidder should have been in operation in India for minimum of three years.

2. The bidder should have provided AMC services of Hardware/Network devices/UPS within Maharashtra.

3. The bidder must have minimum average annual turnover of ₹ 9.93 Lakhs for last 3 audited financial years (FY 16-17, FY-17-18, FY18-19). If the audited balance sheet of FY 19-20 is available then minimum average annual turnover of last 3 audited financial years (FY-

17-18, FY 18-19, FY 19-20) will be considered.

4. The Bidder should have a positive net worth and should be in profit from Hardware/Network devices/UPS service related business in each of the last three audited financial years.

5. The Bidder should have executed either:

1. One similar work order/Contract costing not less than ₹ 26.48 lakhs.

OR

2. Two similar Work Orders/Contracts costing not less than ₹ 16.55 lakhs each OR

3. Three similar Work Orders/Contracts costing not less ₹ 13.24 lakhs each

of AMC/electrical hardware service related business in the last 7 financial Years.

6.The Bidder should be authorized partner/Subsidiary of OEM of UPS for AMC.

7.The AMC service provider should be an ISO 9001:2000 or higher certified company.8.Bidder must be registered for GST.
