Centralized Printing of Electricity Bills in the area of Pune Region of MSEDCL (CE/BILLING/HO/PUNE REGION/T-01/2021)

This Tender of MSEDCL invites sealed online bids from eligible bidders for carrying out the printing of Monthly & Quarterly Electricity Bills and distribution up to subdivision of Pune Region as per MSEDCL Specifications.

Bidders are requested to Note following Revision in Tender -

A) TENDER SCOPE OF WORK (Section -I clause 2 (V), page 9 of 104 and Section- VI clause 1 -printing technology, page no 33 of 104)

Present Clause in Tender:

The Agency shall make use of any High Speed Printing Technology capable of printing one Lakh Bills daily on one machinery adhering to printing quality. (Details of High Speed printing Technology to be submitted by the Bidder in the Tender).

Revision to Clause 2(V) Section I and clause 1(printing technology) section VI:

The Agency shall make use of any High Speed Printing Technology capable of printing one Lakh bills daily on one machinery & with minimum technical specification as below or equivalent-Print speed - 100ppm, A4 paper size, 75 to 100 gsm

Duplex printing, 4 colour printing, high resolution for sharpness and bright highlights. (Details of High Speed printing Technology to be submitted by the Bidder in the Tender).

B) PERFORMANCE SECURITY DEPOSIT (Section-III clause 3, page 19 of 104 and Section V - clause 2, page no 30 0f 104)

Present Clause in Tender:

"The Agency (successful bidder whose bid is accepted by the Company for issue of award for the Tender work) shall have to furnish Performance Security Deposit @10% (Ten Percent) of the contract value in the form of Bank guarantee in the prescribed format from any Indian Public sector/ Nationalized/ Private Sector Bank in favour of "Maharashtra State Electricity Distribution Company Limited", payable at Mumbai within 15(Fifteen) days from the date of Letter of Award."

Revision to Clause 3, Section III:

"The Agency (successful bidder whose bid is accepted by the Company for issue of award for the Tender work) shall have to furnish Performance Security Deposit @5% (Five Percent) of the contract value in the form of Bank guarantee in the prescribed format from any Indian Public sector/ Nationalized/ Private Sector Bank in favour of "Maharashtra State Electricity Distribution Company Limited", payable at Mumbai within 15(Fifteen) days from the date of Letter of Award."

C) FINANCIAL ELIGIBLITY (Section-IV clause 2 (ii), page 27 of 104)

Present Clause in Tender:

In case of JV, Lead partner and other partner should jointly and together meet Turnover requirement. Both their individual Turnover during last 3 financial years duly certified by Chartered Accountant must be submitted in the Bid.

Revision to Clause 2(ii), Section IV:

In case of Joint venture of two firms – Lead partner and other partner should jointly and together meet Minimum Average Annual Turnover (MAAT) requirement, <u>provided that the lead partner must have share at least 51% of MAAT</u>. Their individual Turnover during last 3 financial years duly certified by Chartered Accountant must be submitted in the Bid.

D) Technical eligibility: (Section-IV clause 3- i & ii, page 27 of 104 and Schedule IV – Particulars 3.1 & 3.2, page no 46 of 104)

Present Clause in Tender:

- **3(i)** Must have experience in field of printing of variable data on bills for consumers of any public utility which can be Government / Semi-government / Government Undertaking / Public sector unit / Private sector firm at least for last three (03) years.
- **3(ii)** Must have experience in execution of orders whose Total printing work comes to **minimum Monthly Printing of Bills/documents** in last 3 financial years **equal to @15% of Total consumers in Region.** An experience of printing bills/ documents of variable data or fixed data documents like publications of books . magazines, journals , periodicals, pamplets etc **in one month during last 3 years** taking cumulative of various orders executed in that month for Public sector and Private sector firms will be considered. Necessary documentary evidence will have to be submitted.

Bidder will have to meet the Technical Eligibility specified for the Region in the Tender as follows:-

Revision to Clause 3 (i) & (ii), Section IV in Tender:

3(i) & (ii) - (i) & (ii) - "Must have experience in the field of printing of fixed or variable data such as consumer bills/ <u>publications of books / magazines/ journals/ periodicals/ documents/ pamplets etc.</u> at least for last three **(03) years. Must have** minimum experience of printing at least 11.88 Lakhs documents (any of above) **per month in atleast any three months during last three Financial Years.** Necessary documentary evidence will have to be submitted."

Correction to Clause 2 (XVI foot note **), Section I - Currently the Average Daily Bill Printing work in Pune Region is 79.25 Lakh consumers/<u>25 days</u> = 3.17 Lakhs per day
