1. GENERAL

1.1. Scope of Bid

- 1.1.1.The Maharashtra State Electricity Distribution Company Ltd. (MSEDCL), represented by the Chief Engineer (RE) (hereinafter referred to as "the Employer"), wishes to receive bids for 'Appointment of Third Party Inspection Agency for verification of RFID tags for Solar Photovoltaic Modules installed at different Solar Power Projects located in Maharashtra.
- 1.1.2. The detailed scope of work is attached as Annexure-1.
- 1.1.3. The details of the projects to be verified are provided in the Annexure-2. MSEDCL at its own discretion may increase or decrease the capacity of the projects offered for inspection as per its requirements. The price offered on per module basis shall remain same for reduced/increase project capacity.
- 1.1.4. The contract period is for a period of 2 months. The entire work under this contract shall be completed within a period of 30 days from the date of issue of Letter of Award.

2. BIDDING DOCUMENTS

2.1. Content of Bidding Documents

- 2.1.1. The bidding documents are those stated below, and should be read in conjunction with any Addenda issued.
- 2.1.2.The bidder is expected to examine carefully the contents of the bidding documents. Bids which are not substantially responsive to the requirements of the bidding documents will be rejected.

2.2. Clarification of Bidding Documents

2.2.1.A prospective bidder requiring any clarification of the bidding documents may notify MSEDCL in writing till 20.09.2021 by mail at the address indicated in the Bidding Data. MSEDCL will respond to any request for clarification which it receives earlier than 07 (Seven) days prior to the deadline for submission of bids.

2.3. Amendment of Bidding Document

2.3.1.At any time prior to the deadline for submission of bids, the Employer may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective bidder, modify the bidding documents by issuing addendum.

2.4. Bid Price

- 2.4.1. Bidder shall quote per project (list of projects are given in Annexure-2) fee for the entire service on a 'single responsibility' basis as per the entire scope of work such that the total bid price covers all obligations mentioned there in the tender.
- 2.4.2. Bidder shall quote price bid inclusive of all costs, taxes and levies etc. but exclusive of GST. GST shall be paid extra.
- 2.4.3. Price quoted by the Bidder shall be fixed and not subject to adjustment during the performance of the contract.

2.5. Bid Validity

2.5.1. Bids shall remain valid for the period of 90 days after the date of bid opening.

2.6. Earnest Money Deposit

- 2.6.1.Each Tender shall be accompanied with earnest money of Rs. 1,80,000/- (considering Rs. 10000/- per project) that shall be submitted through Demand Draft in favour of Maharashtra State Electricity Distribution Co. Ltd.
- 2.6.2. Any bid not accompanied by an acceptable bid security shall be rejected by the Employer as non-responsive.
- 2.6.3. The earnest money shall be returned:
 - a. To the unsuccessful bidders after finalization & issue of LOA to successful bidder.
 - b. In case bidding process is terminated by MSEDCL for any reason.
- 2.6.4. The EMD of the successful bidder shall be extended to keep as a security deposit and returned when the bidder has successfully completed the entire work.
- 2.6.5.The EMD of the successful bidder shall be forfeited, if it fails within the specified time to complete the entire work.

3. OPENING AND EVALUATION OF TECHNICAL AND PRICE PROPOSAL

3.1. Opening of Bids

3.1.1. The Employer will open the Bids at the date and time designated in the Tender Notice.

3.2. Evaluation of Technical Proposals and Determination of Responsiveness

3.2.1.The Employer will examine the bids to determine whether they are complete, whether the documents have been properly signed, whether the required security is included, and whether the bids are generally in order. Any bids found to be non-responsive for any reason or not meeting the minimum levels of the performance or other criteria specified in the

- bidding documents will be rejected by the Employer and will not be included for further consideration.
- 3.2.2.A substantially responsive bid is one which conforms to all the terms, conditions and requirements of the bidding documents without material deviation or reservation.

3.3. Opening of Price Proposal

3.3.1.The Price proposals for the technically qualified bidders will be opened on the notified date and time and reviewed to determine whether the price proposals are substantially responsive. Bids that are not substantially responsive are liable to be disqualified at MSEDCL's discretion.

3.4. Award of Contract

- 3.4.1. Work shall be awarded on L1 basis i.e. the successful bidder, who have quoted least price in the Price Proposal.
- 3.4.2. Prior to expiration of the period of bid validity prescribed by the Employer, the Employer will notify the successful bidder by email, that its bid has been accepted.
- 3.4.3. The Employer reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids, at any time prior to award of Contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the grounds for the Employer's action.

3.5. Terms of Contract

3.5.1. The contract shall be valid for a period of 2 months and the successful bidder shall complete the work and submit a detailed report that compares claimed vs actual in terms of module numbers, module capacity, type, make, and country of origin etc. within 30 days from the date of LOA for the specific project.

3.6. Ceiling Rate

3.6.1. The maximum acceptable price bid is Rs. 1 Lakh per project.

3.7. Payment Terms

3.7.1. The assignment has to be completed within 30 days from the date of award of the contract.

3.8. Deviation

3.8.1. The Tender/Bid must comply with the Tender specification and all terms and conditions of contract. No deviation in the Terms & Conditions of the Contract shall be entertained unless specifically mentioned by the bidder in the bid and accepted by MSEDCL.

3.9. Reporting

3.9.1. The successful bidder shall submit the progress report after every week from the date of LOA, towards the module verification done against total scope of 500 module verification for each project location.

- 5. The applicant shall submit a detailed report to MSEDCL that compares claimed vs actual in terms of numbers, type, make, and country of origin of modules, and compare the field inspection data with all invoices data.
