- i. Design, development, maintenance and support of MSEDCL's website.
- ii. Design, development, maintenance and support of MSEB Holding Company's website.
- iii. Immediately takeover existing websites (as it is) of MSEDCL & MSEB holding company and completely overhaul the websites as per MSEDCL's requirements.
- iv. Design, development, maintenance and support of MSEDCL payment reporting portal.
- v. Integration/Maintenance of API for Online Payment with existing or new payment gateway.
- vi. Procurement and deployment of Digital certificates.
- vii. Providing Content Management Services, UI expert services, Website Analytics Services.
- viii. Security Audit for website and payment reporting portal (sr. no. 1,2,3) by CERT-IN empanelled Auditor in every Six Months.

ELIGIBILITY CRITERIA:

- 1. The bidder must be Company registered in India under companies Act 1956 or Companies Act 2013, or Firm registered with Registrar of firms and societies in India who fulfils the eligibility criteria. Bidder should be a single company/firm. No joint venture or consortium or subcontracting is allowed.
- 2. The Bidder should have minimum turnover of Rs. 80 lakhs during each of the last three consecutive financial years i.e. (2017-18, 2018-19, 2019-20) or (2018-19, 2019-2020, 2020-21).
- 3. The Bidder should have positive Net worth after tax during each of the last three consecutive financial years namely (2017-18, 2018-19, 2019-20) or (2018-19, 2019-20, 2020-21).
- 4. The Bidder should have experience of design, development & maintenance of Enterprise level website during past 5 years (up to the date of publishing the tender) in India meeting any of the following condition:
 - a) One work order having annual value of contract not less than Rs. 42.76 lakhs (incl. taxes). OR
 - b) Two work orders each having annual value of contract not less than Rs. 26.72 lakhs (incl. taxes). OR
 - c) Three work orders each having annual value of contract not less than Rs. 21.38 lakhs (incl. taxes). Note: Websites for Government/Govt. Undertaking/ Public Sector Undertaking/Public Utility/ Commercial Banks (Scheduled) / Financial Companies will be considered as Enterprise Websites for above experience.
- 5. The bidder should have experience of handling collection portals with integration of payment APIs for multiple payment gateways with minimum 1,00,000 online transactions on daily basis with regular reconciliation process. *Note: It should be demonstrated on demand.*
- 6. The bidder should have experienced qualified team in the areas of Web-development, UI/UX design, API/Web service Integration, Database technologies, Graphic designing & content management on its payroll for at least 3 years.
- 7. The Bidder should not have been debarred by any Ministry of GoI / GoM / state owned Electricity Distribution utility.
- 8. The Directors, Proprietors, Partners, Employee(s) or owner of the bidder (in case of consortium all members) must not been either jointly or severally proven guilty of malpractices in relation to its business dealings with the Government or MSEDCL during the last five years.
