The Chief General Manager (IT), on behalf of Maharashtra State Electricity Distribution Company Limited (the Employer), hereby invites sealed bids from eligible bidders for *Supply, Installation, Integration, Testing and Commissioning of wired MPLS Leased Lines (1:1) for SCADA project in 7 towns*. Tender Estimate: ₹ 7.84 Crores. (incl. Taxes) for 3 years.

Tender Fee: Rs. 10,000/-Plus GST tax at the rate of 18%.

The bidder should submit non-refundable Bid Fee of Rs. 10,000/- Plus GST extra, in the form of online payment on e-Tendering Website.

Bid Security / EMD: The bid must be accompanied with Bid Security for an amount of ₹ 7,84,044/- (Rupees Seven Lakhs Eighty-Four Thousand and Forty-Four Only). The bid security shall be in the form of Demand Draft or an Unconditional Bank Guarantee from any Nationalized / Scheduled Bank in favour of the Maharashtra State Electricity Distribution Co. Ltd., payable at Mumbai only. The Demand Drafts/BG should be submitted to this office on or before submission date and time.

Brief Scope:

Supply, Installation, Integration, Testing and Commissioning of wired MPLS Leased Lines (1:1) for SCADA project in 7 towns at MSEDCL locations as per "Annexure-III List of Locations of SCADA Wired MPLS Leased Lines".

Qualification Requirements:

- The bidder should be a single company registered / incorporated in India under companies act 1956 and 2013 or LLP with registered office in India and should have been in operation in India. The Bidder should have been in operation for a period of at least 3 years in Telecom industry.
- 2. Bidder should be a National Long-Distance Service Provider or IP VPN service provider/Basic Service Operator having own MPLS Leased line network under license from Govt. of India.

- 3. Bidder should have Supplied, Installed, Integrated, Tested and Commissioned wired / wireless MPLS Leased Lines during preceding seven years (till the date of bid submission) fulfilling either any one of the following criteria:
 - ➤ One similar completed work costing not less than the amount equal to ₹ 6.2 Crore.
 - > Two similar completed works each costing not less than the amount equal to ₹ 3.9 Crore.
 - ➤ Three similar completed works each costing not less than the amount equal to ₹ 3.1 Crore in any sector in India.
- 4. The average annual financial turnover during the last three audited financial years of the bidder should be at least ₹2.35 Crore.
- 5. Bidder (excluding Govt. Organizations/PSUs) should have a positive net worth in any of the last three audited financial years. (FY-17-18, FY-18-19, FY-19-20 Or FY-18- 19, FY-19-20, FY-20-21).
- 6. The bidder should have implemented multi-location WAN Projects (Supply, Installation, Integration, Testing, Commissioning) of MPLS Leased Lines during the last seven years (*till the date of bid submission*) out of which at least one project shall involve Supply, Installation, Integration, Testing and Commissioning of MPLS Leased Lines for a customer having minimum of 50 WAN locations.
- 7. Bidder must be registered for GST and should Provide HSN no. / SAC Code for the items quoted.
- 8. The Bidder should have relevant ISO/BSI or TL9000 certification
- 9. The bidder must not be under a declaration of ineligibility / banned / blacklisted by any State or Central Government / any other Government institutions in India for any reason as on last date of submission of the Bid or convicted of economic offence in India for any reason as on last date of submission of the Bid. Bidder should comply all conditions mentioned in MSEDCL POLICY & PROCEDURE FOR DEBARRING OF AGENCY (enclosed as Appendix 1).
