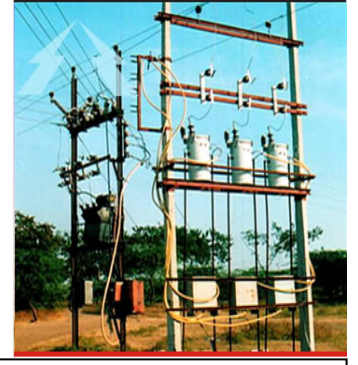


**MAHARASHTRA STATE

1. Pre-requisites & other Conditions:

Qualification: Should have worked in the capacity of District & Session Judge at least for the period of 3 years.

Upper age limit : Should not be more than 62 years of age.

Period of Contract: The period of contract will be of three years **OR** till attaining the age of 65 years, whichever is earlier.

Remuneration & Perquisites: Rs. 35,000/- (Rupees Thirty Five Thousand only) consolidated per month during the period of contract. The candidate should write his Full Name on the backside of the Demand Draft. Fees in the form of Postal Order/Money Order/Cash will not be accepted.

5. Selection Process:

- 5.1 Prescribed qualifications are minimum and mere possession of the same does not entitle the candidate to be called for interview. The candidates will be short listed commensurate with the number of vacancies.
- 5.2 The details of interview schedule will be communicated to the short listed candidates by e-mail, telephonically. The call letter for personal interview will not be sent.
- 5.3 The list of applicants short listed for selection process will be made available on the website of the Company. Similarly the list of finally selected candidates will also be displayed on the website.
- 5.4 The short listed candidates will have to appear for the Personal Interview at their own cost. Traveling expenses will not be reimbursed.
- 5.5 The recruitment in MSEDCL is done strictly as per merit in a systematic way.
- 5.6 Canvassing in any form will disqualify a candidate.
- 5.7 If any false/incorrect information furnished by the candidate is detected at any stage of recruitment process, his/her candidature will not be considered.
- 5.8 If the candidate knowingly or willfully furnishes incorrect or false particulars or suppresses material information, he/she will be disqualified and if appointed, shall be liable for dismissal from the Company’s service without any notice or assigning any reasons whatsoever.
