1. The consumer complainant M/S Ganesh Starch & Sago Industries ( Con.No. 514406607247 IP) through its partner has filed his grievance in Annexure “ A “ before this Forum on 07.11.2005 under regulation No. 6.5 of The Regulations 2003. A copy of the grievance was forwarded on 08.11.05 to the Nodal officer and Executive Engineer (Adm) in the office of the Superintending Engineer, Jalna with a request to furnish his response on the grievance within a period of fifteen days and hearing in the matter was fixed on 25.11.05.
2. The grievance of the consumer in brief is as stated below. The Consumer has applied for electrical connection for his Factory at Rajur Taluka, Bhokardan,Dist.Jalna It is contended that the consumer has paid Rs.92790/ on 23.07.1992 for an independent transformer substation for his small scale industry at Rajur.,Taluka Bhokardan. It is further contended that since he has paid the entire amount as per directives of the MSEB, he is the owner of the transformer substation. It is further contended that the transformer was removed and shifted by the MSEB. without any prior intimation to him in the year

1994-95. The consumer requested that the amount paid by him along with interest should be refunded to him by MSEB.

3. The response of the Nodal officer was received on 25.11.05. In the response it is stated that though the ORC charges is paid by the consumer the asset created becomes property of MSEB and since the consumer was permanently disconnected on 15.07.2000 the D.L. has right to shift the transformer erected for the consumer.
4. Hearings in the matter were taken on 25.11.05, 01.12.05, 20.12.05, 27.12.05 and 29.12.05 and the grievance was reserved for decision.
  1. However before the decision could be given , the consumer on 02.01.2006 filed application stating that he is withdrawing his grievance as he intends to file legal proceeding for justice in the matter. The request of the consumer to withdraw the grievance is allowed . Hence the following order.

**The grievance of the consumer stands discharged as he is permitted to withdraw the grievance in view of the withdrawl application filed by him.**

**Inform the parties and close the case.**
