REDRESSAL - ORDER

1. The Grievance of the complainant is against the bill dated 4.4.2013 issued for the sum of Rs.5,87,880/-

2. The case of the complaint in brief is that, the complaint is the consumer bearing consumer No .493029040800. The nature of consumer is Indistinct
3. Dt. 18.04.2013 the complainant received a demand Letter, making demand for the sum of Rs.587880 toward tariff difference for the period of Nov. 2008 to Oct. 2008. The letter of demand was annexed with threat of disconnection of supply. It is therefore prayed that, demand for payment of Rs. 5,87,880/- may be quashed as the same is beyond period of limitation of two years and further prayed that, respondent be directed, not to disconnect the power supply.
4. The respondent has submitted reply and thereby submitted that, flying squad Inspected the unit of complainant on 3.9.2010 and found that the use of power is for commercial and not for Industrial , The flying squad thereby changed tariff from HT-1-N to HT-1-c The bill of difference of tariff was issued for the period of June 2008 to Oct 2010. As per Order passed by this forum, the bill was restricted for 24 months amounting to RS. 5,87,880, The respondent gave details bills, on 18.5.2013
5. This forum heard the submissions of Mr. Kapadiya for the complainant Mr. Nitawre the nodal officer represented the MSEDSCCL
6. During the arguments, it is noticed that the present grievance regarding application of tariff has already been decided by this Forum in case No CGRF/AZ/Aur/316/2010/43. The copy of the Order has been produced.

7. Mr. Kapadiya for the complainant conceded the Liability of the payment of disputed bills. The only prayer which he has made is of monthly installments comprising of one Lakh each in addition to his regular bills. The nodal officer Mr. Nitnawre has stated no objection for granting such installments. Hence in view of such undisputed position, This Form proceeds to pass the following Order of redressal of Grievance .

Order

1. The complainant is hereby permitted to pay the arrears of bill of RS. 5,87,880/- in six installments.
2. The arrears shall carry 12% p.2 Simple interest.
3. Five installments shall be for ONE LAKH each payable month. In addition to regular bill, the sixth installment shall be of balance arrears.
4. Interest @ 12% p.a. Shall commence form the date of the demand notice till payment of the respective amount of the bills
5. No Order as to cost.
