INTERIM ORDER

The consumer has filed an application in the Forum along with all the relevant bills issued by Distribution Licensee . The consumer has paid all the bills till May 2007. The Distribution Licensee issued him bill for the period 5.6.07 to 5.7.07 for Rs. 1,50,715/-. Aggrieved by this , consumer requested the Forum to direct the D.L. not to disconnect his electricity supply by way of interim order.

On hearing both the parties, prima-facie, Forum observed that the bill issued by the D.L. for the period 5.6.07 to 5.7.07 is not correct and therefore as per provision No.6.5 of the Regulation , hereby direct the D.L. not to disconnect the electricity supply of the consumer.

This Interim order shall be subject to final decision on the grievance of the consumer, that may be passed.
