**INTERIM ORDER**

The consumer has filed an application in the Forum along with disputed bill dt. 27.09.07 issued by Distribution Licensee . The consumer is regular payer of electricity bills issued by the Distribution Licensee. The Distribution Licensee issued him bill on 27.09.07 for Rs. 2,50,636/ . Aggrieved by this , consumer requested the Forum to direct the D.L. not to disconnect his electricity supply by way of interim order.

On hearing both the parties, prima-facie, Forum observed that the bill issued by the D.L. for Rs. 2,50,636/ is on account of irregularity on the part of D.L. The bill issued to the consumer also do not show any details.

**As per provision 6.5 of the Regulation of M.E.R.C., Forum hereby direct the D.L. not to disconnect the electricity supply of the consumer till the grievance of the consumer is disposed .**

This Interim order shall be subject to final decision on the grievance of the consumer, that may be passed.
