Appellant Shri Saturdekar had submitted his grievance on 15/02/2007 which was registered with the Forum at Sr. No. 110. The date of hearing was fixed on 28/03/2007 at 11.30 am at the office of CGRF, Bhandup.

The appellant has put his postal address on the form of Redressal of grievance in schedule "A" as under

C-1-57-A, Wing A/202, Shree rang Co.Op. Housing Society, Thane (West).

He was intimated to attend the hearing by sending a registered letter on the above address which was returned undelivered. The appellant had mentioned in his application form, his mobile phone No. 9821741618. He was contacted on this phone. He stated on phone as under :

"He has booked a residential flat in the above mentioned Co.Op Housing Society and completed all financial obligations with the builder. He also paid all necessary charges for new electric connection with the utility. However he could not get the electric connection, in the mean time, the Managing Committee of the Society approached Civil Court, Thane against the builder of the building from which the appellant and others purchased the flat.

The Civil suit No. 221/2005 in Thane Court is still undecided and the Court has passed the orders to maintain the status - quo and as such the utility cannot provide electric connection to the appellant." Realising the plea of the appellant that he cannot shift to stay in the flat purchased by him for want of electric connection which is a basic necessisity, he was advised to approach the Court with a request to allow him to avail of the electric connection, since, he is not concerned with the dispute between the builder and the society. He agreed to do so.

In these circumstances, it is felt that the Forum cannot intervene in the matter of grant of electric connection to the appellant unless the Hon'ble Civil Court, Thane passes orders withdrawing status-quo granted in the matter.
