1) Consumer Grievance Redressal Forum has been established under regulation of "Maharashtra Electricity

Regulatory Commission (Consumer Grievance Redressal Forum & Ombudsman) Regulation, 2003" to redress the grievances of consumers. This regulation has been made by the Maharashtra Electricity Regulatory Commission vide powers conferred on it by section 181 read with sub-section 5 to 7 of section 42 of The Electricity Act, 2003. (36 of 2003).

2) The consumer is LT consumer of the licensee connected to their 415 volt LT network. The consumer is billed on residential tariff. The consumer registered grievance with forum on 9/10/05. The details are as follows.

Name of consumer: - Shri. Sanjeev Borade.

Address: - Same as above

Consumer No.: - 020150046026.

The electric bill stands in the name of M/s. Lok Developers 301/B-3, Lokgram, Netivali, Pin 421301 & Shri Sanjeev Borade is the consumer using energy for residential purpose. Reason of dispute: The consumer received bill of Rs. 71,000/- as his meter was found to the slow by 88% during testing on 18/10/2004 and the meter seals were found damaged.

- 3) The batch of papers containing above grievances was sent by forum vide letter No. 0300 dated 19/09/2005 to Nodal Officer of licensee. The letter, however, remain unreplied.
- 4) All three members of the forum heard both the parties on 10/10/2005 and 24/10/2005.

Grievance No.K/E/028/0030 of 05-06

- 5) Licensee vide letter No.1720 dated 14/10/2005 submitted final assessment sheet amounting to Rs.71, 215/- for 88% slow meter recording consumption. Licensee also submitted spot inspection report dated 18/10/2004 and panchanama dated 27/09/2003 indicating that the case falls under the scope of Section 135 of Electricity Act, 2003. Licensee also vide letter No.02055 dated 24/10/2005 submitted that the case is being filed in the court for theft of energy as per Section 135 of Electricity Act 2003, and as such this matter does not come under purview of CGRF.
- 6) On study of inspection report and panchanama, CGRF agrees with the view of licensee and as such the case is disposed of as it does not come under the purview of CGRF.
- 7) No order is passed by CGRF.
