<u>ORDER</u>

(Passed this 2nd day of March,2009) (Per Shri V.R. Khobragade, CHAIRMAN)

- Being no communication in response to the application made on 17/10/2008 to IGRC, Wardha, One Shri Nagose, filed an application to Forum 12/1/2009, seeking necessary relief of compensation to the Applicant as admissible as per provision contained in SOP,2005.
- 2. After receipt of his application, the Forum issued acknowledgement to Applicant, called parawise comments of the non-applicants(hereinafter called 'DL'/'NA'), a copy of the parawise comments was sent to the Applicant, issued notices to both the parties, finally heard both the parties on 16/2/2009. Forum thus, offered a fair, reasonable and adequate opportunity to both the parties for submission of their say in the matter.

- 3. On the date of hearing both the parties were present. They were heard. Both the parties reiterated same points.
- 4. On going through the records carefully, it is noticed that the application made to Forum was duly signed by the Applicant Shri Prabhakar Mahadeorao Chopade (Record page-1) and the application filed before IGRC, Wardha is signed by one Shri Prabhakar Keshaorao Khawashi (Page 2) It is further noticed that no copy of order passed in the matter is produced either by the Applicant's representative or the NAs. Since there has been no communication from IGRC to the Applicant Shri Prabhakar Chopade, Forum find it mandatory to submit the grievance application in schedule form 'A' under his signature alongwith a copy of application filed to IGRC, Wardha.
- 5. Under the circumstances as discussed above, the application filed before Forum is not maintainable and thus the application is rejected. Forum further point out that the Applicant Shri Prabhakar Chopade has right to approach to Forum on receipt of copy of the order within time prescribed or the Applicant or his duly nominated representative keeps his right reserve to approach to Forum, if there is no any communication on the application filed before IGRC, Wardha.
- 6. With the above observations, the Forum unanimously pass the following order.

-: ORDER :-

1. Application is not maintainable, thus rejected.

2. Chairman, IGRC, Wardha is directed to communicate an order passed by the cell to the applicant.

3. Parties to bear their own costs.

4. Parties be informed suitably.
