ORDER

(Per Shri V.R. Khobragade, CHAIRMAN)

1. One Shri Nagose, Representative of Shri P.G.Kokate R/O Saoli(Khurd) (hereinafter referred to 'Applicant') filed an application dtd. 13/1/2009before this Forum in schedule form 'A' as per MERC (CGRF&EO) Regulations,2006 (hereinafter called the 'Regulations').
2. After receipt of his application, the Forum issued acknowledgement to Applicant, called parawise comments of the non-applicants(hereinafter called 'DL'/'NA'), a copy of the parawise comments was sent to the Applicant, issued notices to both the parties, finally heard both the parties on 12/2/2009. Forum thus, offered a fair, reasonable and adequate opportunity to both the parties for submission of their say in the matter.

3. Shri P.G.Kokate, the Applicant was represented through Shri Nagorao Dewase. The representative requested for compensation on the issue as mentioned in application filed before the Forum.
4. Shri M.B.Dhabarde, A.E. represented the case for company. He reiterated the same points as mentioned in the parawise comments submitted to the Forum.
5. On the date of hearing Forum observed that an application by shri Panjabrao Kokate dated Nil bears thumb impression (Page 20) whereas the application presented through representative on 12/1/2009 bears Marathi signature of Shri Panjabrao Kokate(Record Page 1). The representative was therefore directed to remain present alongwith Shri Panjabrao Kokate. Shri Kokate appeared on 25/2/2009 before Forum. The said application date. 12/1/2009 was shown to Shri Panjabrao and he denied his signature thereon and stated that he is an illiterate fellow and does not know about the application filed before Forum.
6. Considering the facts as mentioned above, the Forum come to conclusion that fake application date. 12/1/2009 filed before Forum deserves no consideration. Thus, the application filed through representative is rejected .
7. With the above observations, the Forum unanimously pass the following order.

1. The case is rejected and order passed by Cell is confirmed.
2. Parties to bear their own costs.
3. Parties be informed accordingly.
