- Being aggrieved with the order of I.G.R.C., Wardha passed in case, the Applicant filed an Application in form schedule 'A' as per MERC (CGRF&EO) Regulations, 2006 to Forum on 5<sup>th</sup> February,2009 requesting to grant compensation as per provision in force.
- 2. After receipt of his application, the Forum issued acknowledgement to Applicant, called parawise comments of the non-applicants(hereinafter called 'DL'/'NA'), a copy of the parawise comments was sent to the Applicant, issued notices to both the parties, finally heard both the parties on 19/3/2009. Forum thus, offered a fair, reasonable and adequate opportunity to both the parties for submission of their say in the matter.

- On the date fixed for hearing, representative of the Applicant was heard. Shri S.M.Ghade,E.E., Shri R.K.Giri,Dy.E.E. and Shri A.G.Kadam, J.E. were present for non-applicants and they made their submission in the matter.
- 4. On going through the case papers, Forum expressed doubt regarding signature of the Applicant . Forum, therefore, directed representative to remain present alongwith the Applicant on 23/3/2009. On 23/3/2009 representative alongwith Shri Marotrao Zade, father of Applicant came to Forum. Shri Marotrao Zade admitted that he had signed for his son Vinod. The Forum explained the legal procedure. Shri Vinod has, since been a major, Shri Marotrao has no right to file application on his behalf. The application is , therefore, carries no validity. The Forum thus unanimously pass the following order.
