JUDGEMENT

(Delivered on this 08th day of May, 2014)

2. The applicant Shri Nanaji Pandurang Urkude, At.Shegaon Po.Washi Tq.Samudrapur, Dist.Wardha submitted this grievance application through his authorized representative Shri B.V.Betal. The applicant stated that the respondent MSEDCL gave illegal electricity connection to one Smt. Lilabai Rambhau Patil.

3. The respondent was noticed. On 05-05-2014 Shri M.S.Vaidya, Executive Engineer, Hinganghat was present for the respondent. Both the parties were heard.

4. Shri B.V.Betal, argued that Smt. Lilabai Rambhau Patil is his adjacent land holder. She already has one electricity connection. She applied for another connection.

The connection was to be given under zero pole category. One Junior Engineer of the respondent gave one illegal connection to Smt. Patil. The connection has been given from the pole which is standing on the boundary of the applicant. The applicant made the complaint about the illegal connection to the Assistant Engineer, Samudrapur. So on 30-01-2014 this illegal connection was taken away.

5. In reply, Shri Vaidya stated that on receipt of the complaint, from the applicant, he carried out the spot inspection. Smt. Lilabai R. Patil has been given a legal connection as per rule. No illegal connection, as alleged, was noticed on the spot. The applicant has already been informed accordingly.

6. We have perused the record. We have heard the arguments advanced by both the parties. The applicant stated that Smt. Patil has been given the illegal connection. However he could not establish any way as to what loss or damage is caused to him in this incident.

7. So we are not inclined to entertain the application, it deserve to be dismissed. The applicant may approach the appropriate authority of the MSEDCL.

So we pass the following order,

<u>ORDER</u>

- i) The application No.42 of 2014 is hereby dismissed.
- ii) The parties to bear their own cost.
