- Shri A.S.Dhobale R/o. Saoli(khurd) (hereinafter referred to 'Applicant') has filed grievance application in schedule form 'A' as per MERC(CGRF&EO) Regulations,2006 (hereinafter called the 'Regulations')on 13/1/2009. His grievance is regarding not providing electrical connection to agricultural pump by M.S.E.D.C.L. at village Saoli(Khurd) Taluka-Karanja(Ghadge), District-Wardha despite completing all the formalities i.e. payment, submission of test report.
- 2. After receipt of his application, the Forum issued acknowledgement to Applicant, called parawise comments of the non-applicants(hereinafter called 'DL'/'NA'), a copy of the parawise comments was sent to the Applicant, issued notices to both the parties, finally heard both the parties on 12/2/2009. Forum thus, offered a fair,

reasonable and adequate opportunity to both the parties for submission of their say in the matter. Both the parties were heard on 12/2/2009.

- 3. During the course of scrutiny of the documents Forum observed that signature of Applicant bearing on application e.g. Appendix 'A' (Record page 11) and the Applicant's signature on Schedule 'A' (record Page 1) does not tally. The representative was therefore directed to remain present on 16/2/2009 alongwith the Applicant Shri Anil Dhobale. The Representative Shri Dewase appeared on 16/2/2009. The Applicant Shri Anil Dhobale did not care to communicate any reason for his absence on the date fixed for nor he did apply for time. The Applicant did not avail of an opportunity to prove genuineness of his signature. The substantial discrepancies in signature helps to come to conclusion that the signature on Schedule 'A' seems to be fake one.
- 4. Under these circumstances, the Forum unanimously pass the following order

#### -: <u>ORDER</u> :-

- 1. The application is dismissed in default.
- 2. Parties to bear their own costs.
- 3. Parties be informed suitably.
