JUDGEMENT

(Delivered on this 12th day of August, 2015)

2. The applicant submitted this grievance application before this forum and claimed compensation. He alleged that the respondent failed to release the connection within the stipulated time period.

Both the parties were heard on 11-08-2015. It is admitted fact that the applicant submitted an application for agricultural connection. A demand note was issued. He deposited the required amount. Finally he submitted the test report on 16-05-2015. According to respondent it is necessary to lay LT line admeasuring 0.18 km to release the connection to the applicant.

As per the provisions contained in Regulation 4.8,

Where the supply of electricity to a premise requires extension or augmentation of distributing mains, the Distribution Licensee shall give supply to such premises within three (3) months from the date of receipt of the completed application and payment of charges.

In the instant case the applicant submitted test report on 16-05-2015. So he is entitle for connection on or before 16-08-2015. However the applicant approached the IGRC Wardha and this forum before the stipulated period is over. Naturally, the application is premature.

So we pass the following order,

ORDER

- Application no.68 of 2015 is hereby dismissed. The applicant may approach
 IGRC Wardha after the stipulated time period is over.
- ii) No order as to cost.
