ORDER PASSED ON 22.7.2014.

1. The applicant filed present grievance application before this Forum on 17.6.2014 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as Regulations).

2. The applicant's case in brief is that he claimed change of tariff from LT-I to HT-VI. His grievance was not redressed. Therefore applicant filed case No. 298/14 and Learned I.G.R.C. passed order dated 28.4.2014. Being aggrieved by the said order the applicant filed present grievance application before this Forum.

3. On the date hearing the applicant had withdrawn the application and gave endorsement in writing below his signature at the bottom of grievance application Schedule 'A'.

Record shows that it is specifically pointed out in the order of Learned I.G.R.C. that power supply is used for mixed load of RL (housing purpose & commercial purpose) but no submeters are provided by the applicant which are essential for applicability of HT-VI category. In view of above, the request of applicant for change of tariff cannot be considered. It is further ordered by the Learned I.G.R.C. that for getting the benefit of HT-VI category the applicant has to bifurcate the RL & CL load separately by separate meters. It is the order Dt. 28.4.2014 passed by Learned I.G.R.C. in Case No. 298/14. During the course of hearing the Forum put up a query to the applicant as to whether he complied this order and applicant replied 'Yes'. Applicant bifurcated RL & CL load separately by separate meter. Therefore now the applicant has to apply afresh to SNDL that he has complied the order of Learned I.G.R.C. and change of tariff should be given to him. Incase his grievance is not redressed by SNDL, he is at liberty to approach I.G.R.C. The applicant understood this technical situation and therefore withdrawn his application. Therefore it is necessary to dispose off the application. Hence the following order : -

ORDER

- 1) Applicant has withdrawn the application. Therefore the application is disposed off.
