ORDER PASSED ON 30.7.2013.

1. The applicant filed present grievance application before this Forum on 1.6.2013 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as Regulations).

2. Applicant's case in brief is that previously there was old meter installed at the premises of the applicant but now it is changed and replaced. Therefore the applicant is receiving excessive bills. Therefore the applicant claimed to test the meter in the laboratory of M.S.E.D.C.L. and to revise the bill.

3. Non applicant denied applicant's case by filing reply dated 15.6.2013. It is submitted that in November 2010, M.S.E.D.C.L. had replaced old meter and new meter No. 14499884 was installed. On request of the applicant it was tested in presence of the applicant and meter is found O.K. The applicant filed application before I.G.R.C. which is rejected. Grievance application may be dismissed.

4. Forum heard arguments of both the sides and perused the record.

5. During the course of hearing dt. 17.6.2013, it is ordered by the Forum that meter of the applicant be tested in the laboratory of M.S.E.D.C.L. in presence of the applicant and Member / Secretary of the Forum and to submit the report. Accordingly meter of the applicant was tested in the laboratory of M.S.E.D.C.L. in presence of applicant and Member / Secretary of the Forum. Dy. Exe. Engineer Testing Dn., (U), Nagpur filed testing report Dt. 24.7.2013 on record which shows that the meter is O.K.

6. Therefore consumption recorded by the meter is the consumption utilized by the applicant and hence there is no scope for any revision of the bill. There is no force in grievance application and the application deserves to be dismissed. Hence Forum proceeds to pass following order : -

ORDER

- 1) Grievance application is dismissed.
