ORDER PASSED ON 27.02.2017.

1. The applicant filed present grievance application before this Forum on 10.01.2017 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as said Regulations).

2. Applicant's case in brief is that he applied for agricultural connection on 25-02-

2013. Demand was issued on 07-05-2013. Applicant paid amount of demand on 07-

06-2013. Test report is submitted on 09-07-2014. Supply is not released therefore

applicant approached to this forum.

3. Non applicant, denied applicant's case by filing reply dated 27.01.2017. It is submitted that labours of the contractor went to the premises on 21-09-2016 and again on 18-10-2016 but applicant obstructed them and did not allowed to work. Applicant gave in writing to carry out the work after 3 month as the crops were standing on 18-10-2016. Again on 22-01-2017 workers went to complete the work and erected 3 poles but applicant obstructed them. Officer of MSEDCL found that no installation was prepared by the applicant. There was no capacitor and there was no earthing, test report of the applicant was cancelled on 23-01-2017. Detailed panchnama was prepared. Panchnama is produced on record. On the report of MSEDCL offence U/s.353 IPC was registered against the applicant.

4. Forum heard arguments of both the sides and perused record.

5. Date of application is 25-02-2013. Demand is issued on 07-05-2013 therefore claim for compensation for late demand is barred by limitation according to Regulation 6.6 of the said Regulation. During the pendency of this matter there was compromise between the parties out side the forum on 23-02-2017. Applicant gave statement before panch that criminal offence was registered against him on the report of MSEDCL and he was called in the police station. Police prepared spot panchnama and conducted enquiry. Now he co-operated for erecting electric poles and other work and electricity supply is released to him. Meter is installed and supply is given. Now applicant has absolutely no any complaint against MSEDCL. It is noteworthy that this statement of the applicant dated 13-02-2017 is produced before the forum, it is signed by the applicant, 2 panchs and even representative of the applicant Shri Betal.

6. Therefore it is cleared that applicant has no complaint against MSEDCL regarding any matter and the matter was compromised. Therefore grievance is redressed.

7. Hence we proceed to pass the following order.

ORDER

 Grievance is fully redressed therefore grievance application is hereby disposed off.
