ORDER PASSED ON 17.01.2017.

1. The applicant filed present grievance application before this Forum on 02.12.2016 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as said Regulations).

2. Applicant's case in brief is that he received excessive bill for the month of December-2015 therefore bill may be revise.

3. Non applicant, denied applicant's case by filing reply dated 23.12.2016. It is submitted that meter was send for testing on 09-09-2015 and as per testing report meter is O.K. IGRC dismissed the grievance application of the applicant on the ground that there is same trend of consumption. Grievance application deserves to be dismiss.

4. Forum heard arguments of both the side and perused record.

5. According to applicant his bill for the month of December-2015 – 1049 unit is excessive. However we have perused consumption trend of the applicant. In September-2015 and October-2015 there was RNA status and bill was 1477 units for 3 months issued in November-2015. In December-2015, consumption is 1049 units. However in June-2015 also consumption was 1496 units. In May-2015 consumption was 2329 units. Therefore there is same trend of consumption. In January-2015 also consumption was 1133 units, in December-2014 – 1230 units, in November-2014 – 1288 units, in October-2014 – 1345 units, **in August-2014 – 4714 units**, in June-2014 – 2097 units. Therefore in other months, there was even more consumption than December-2015. Applicant is running a Beer Bar at village Sirsi near Umred Town. After all consumption is depend on the use and utilization of electricity. Meter is tested by MSEDCL and it is found O.K. Therefore electricity supply consumed by the applicant is correctly recorded by the meter. Spot inspection report shows heavy connected load. We can understand working hours of Beer Bar in rural area and it can be open even up to midnight.

6. Therefore there is no scope for revision of the bill. Grievance application deserves to be dismiss.

7. Hence we proceed to pass the following order.
