The applicant has approached this Forum in respect of excessive billing for the month of October, November, 2009 According to him, the excess billing is due to faulty meter. The respondent has filed his reply on 30.12.2009. The respondent has stated the electric bill of the consumer is corrected. Considering the faulty status of the meter. The consumer is given the bill of Rs. 635/- and the old faulty meter is now changed.

Heard both the parties that the applicant has seen the reply filed by the non-applicant. He is satisfied about the corrected bill and change of meter.

The consumer does not have any complaint. The grievance is settled between the parties. Hence, there is no need of any order.

We are satisfied that the consumer's grievance is now resolved. There is no need of any formal order.

Therefore, the case is disposed off accordingly.
