The present grievance application has been filed on 06.04.2010 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 here-in-after referred-to-as the said Regulations.

The consumer has approached to this Forum on dated 06.04.2010 and requested to

- a) Reduce the contract demand of applicant from second billing cycle from the date of application i.e. from the billing cycle for the month of August, 2009.
- b) Provide compensation for delay in release of reduced demand as per SOP Regulation.
- c) Refund the excess minimum demand charges alongwith power factor penalties depending on new calculations of energy bills as per reduced contract demand to be charged by MSEDCL after second billing cycle along-with interest under section 62 (6) of the Electricity Act, 2003.

The applicant has filed their letter wherein the applicant has stated about the joint agreement between both the parties, the nonapplicant has agreed and accepted the contains of the letter. It is clear from the said letter that the non-applicant has agreed to reduce the contract demand of the applicant effective from August, 2009. The nonapplicant has also agreed to refund an amount of Rs.3,46,480=50 to the applicant. The applicant has agreed to withdraw his prayers as clause no. (B) & (C).

After reviewing the submission of both the parties and verifying the contains of letter filed to-day. The following order is passed.

ORDER

- 1) The grievance application is partly allowed. The nonapplicant is directed to reduce the contract demand to the applicant from billing cycle for the month of August, 2009.
- 2) The non-applicant is directed to refund an amount of Rs.3,46,480=50 to the applicant.

In view of the above, withdrawal of prayers (B) & (C), no order is necessary in respect of these prayers.

The non-applicant shall carry out this order and report compliance to this Forum on or before 31.05.2010.
