- 3. Non-applicant denied the applicant's case by filling reply dated 23.03.2017. It is submitted that it is necessary to install 0.12 km LT line. Grievance application deserves to be dismiss.
- 4. Forum heard arguments of both the side and perused record.
- 5. During the course of argument, application sent by applicant dated 22-03-2017 is produced on record. In this application of the applicant, applicant voluntarily submitted that there is no harassment to the applicant by MSEDCL and he withdrawn his grievance application. This withdrawal pursis of the applicant is signed in English.
- 6. Therefore it is clear that applicant withdrawn his case and he don't want any compensation and grievance application deserves to be dismiss.
