**ORDER PASSED ON 23.01.2017.**

1. The applicant filed present grievance application before this Forum on 23.12.2016 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as said Regulations).

2. Applicant's case in brief is that his bill for April and May-2016 is excessive and therefore it may be revise.

3. Non applicant, denied applicant's case by filing reply dated 02.01.2017. It is submitted that there is heavy connected load. Meter is tested and found O.K. Grievance application deserves to be dismiss.

4. On the date of hearing dated 17-01-2017 and again on 23-01-2017 applicant was absent. He did not file application for adjournment.

5. Forum heard arguments of non-applicant side and perused record.

6. Spot inspection report shows that there are 5 Fans, 6 Tube lights, 4 CFL, 2 TV, 2 set top box, 2 Freeze, 2 mixtures, 2 A.C. and 2 Washing machine. It means 2 families must be residing there and it means that there is heavy connected load. April-2016 consumption is 701 units and May-2016 – 828 units. Consumption trend of the applicant shows i.e. in June-2014 consumption is 501 units, April-2015 – 355 units. In May-2015 – 633 units, June-2015 – 738 units and in June-2016 – 1034 units. Therefore there is same trend of consumption.

6. Meter is tested in laboratory of MSEDCL and as per meter testing report dated 02-12-2016 meter is O.K. Grievance application for revision of bill deserves to be dismiss.

7. Hence the following order.
