- 1. The Applicant filed present grievance application before this Forum on 21.04.2017 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as said Regulations).
- 2. Applicant's case in brief is that, he applied for getting new electric connection vide application no.1435896241. But his application is rejected by NSC-In charge due to old PD due of Rs.21140/- against old PD connection no.410011478381 in the same premises. Therefore he approached before IGRC. During hearing at IGRC, in case No.0160/2017 dated 07-04-2017, the applicant agreed and asked permission to

deposit only 6 months current bills of old PD connection prior to the month of permanent disconnection instead of total PD arrears of Rs. 21140 /- as per clause no.10.5 of MERC's supply code and regulation 2005. However, as the connection was permanently disconnected by then MSEB before Jan-2003, due to judicial constraint, applicant's grievance could not be redressed by IGRC. Therefore he approached to this forum.

- 3. During the hearing, Nodal officer, MSEDCL in his written reply agreed to inform the consumer, the amount towards 6 months current bills of old PD connection prior to the month of permanent disconnection as per clause no.10.5 of MERC's supply code and regulation 2005. He further stated that, in case the said amount is paid, the new connection can be released to the applicant.
- 4. Today on 18-05-2017 applicant filed pursis, that he has deposited Rs.2995/-, the bill amount limited to 6 months as per clause no.10.5 of MERC's supply code and regulation 2005 on dt.17/05/2017. Hence he doesn't want to proceed with the case and therefore he is withdrawing the case.
- 5. As per request of applicant he withdrawn his case therefore case is withdrawn and proceedings is closed.
- 6. Hence the following order.

Application had withdrawn his case therefore case is withdrawn and proceedings is closed.
