- 2. The applicant's case in brief is that applicant applied for new service connection as per application No. 14/3/1/3788. But no connection was given. P.D. arrears against three numbers of consumers are outstanding against the same premises namely 1) Shri Mohd. Shahjad Qureshi 2) Mohd. Nabab Qureshi 3) Abdul Razzak Abdul Rehman. Applicant approached to I.G.R.C. and

Learned I.G.R.C. passed order dated 30.5.2014. However, applicant is not satisfied with that order. Therefore applicant approached to this Forum.

- 3. Non applicant denied applicant's case by filing reply dated 19.6.2014.
- 4. Forum heard arguments of both the sides and perused the record.
- 5. During the course of arguments both the parties filed pursis Dt. 20.6.2014 on record to the effect that applicant is ready to deposit part of his P.D. arrears amount Rs. 3026/-. SNDL also gave in writing that if amount of Rs. 3030/- is paid by the consumer, non applicant is ready to give new connection. Therefore matter is amicably settled between the parties. Hence following order:

ORDER

- 1) Grievance application is partly allowed.
- 2) Applicant shall deposit part of P.D. arrears amounting to Rs. 3026/- and on such payment and on compliance of requisite formalities non applicant shall give fresh connection to the applicant.
- 3) Non applicant to report compliance within 30 days from the date of this order.
