- 2. The applicant's case in brief is that his Security Deposit amount Rs. 3051/- is not appearing in the Electricity Bill and it should be shown along with interest.
- 3. Non applicant M/s. SPANCO filed reply Dt. 26.4.2013 on record to the effect that electricity supply is given to the applicant by M.S.E.D.C.L. on 5.4.2011. Therefore applicant should produce original receipt of Security Deposit. On such production, non applicant M/s. SPANCO is ready to make corrections and interest will be given as per rules.
- 4. Forum heard arguments of both the sides and perused the record.
- 5. During the course of hearing, the applicant produced original receipt of Security Deposit for Rs. 3000/- Dt. 19.3.2011. Forum verified the zerox copy of that receipt from the original and returned the original to the applicant. Original receipt is also shown to the officers of M/s. SPANCO and M.S.E.D.C.L. before the Forum. Therefore it is necessary to correct the electricity bill. Hence the following order:-

1) Grievance application is allowed.
