1. The applicant filed present grievance application before this Forum on 28.3.2013 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as Regulations).

- 2. The applicant's case in brief is that he filed an application for new service connection but his application is rejected. Therefore applicant approached to this Forum for issuance of new connection.
- Non applicant denied applicant's case by filing reply Dt. 23.4.2013. It is submitted that proper is owned by Shri Anandrao Gadekar as per tax receipt of N.M.C. One connection is already given in the name of Shri Bisan Arjun Gadekar. Therefore another connection can not be given according to clause 2.2.5 of terms and conditions of M.S.E.D.C.L. The applicant did not produce registered document of title. Application may be dismissed.
- 4. Forum heard arguments of both sides and perused record.
- 5. Applicant produced notarized document of possession certificate / N.O.C. executed by Shri Anandrao B. Gadekar in the name of the applicant. Applicant also produced his own ration card in which name of the applicant, his wife, daughter and son are shown. Documentary evidence on record shows that applicant is residing separately and user within the meaning of relevant regulations and provisions of Electricity Act 2003. Therefore he is entitle for separate electricity connection. Hence following order:-

ORDER

1) Grievance application is allowed.

- 2) Non applicant is directed to issue demand note for new connection.
- 3) On receiving such demand note applicant shall deposit amount of demand note and shall comply other requisite formalities. On completion of these formalities by the applicant non applicant shall issue new electricity connection to the applicant.
