1. The applicant filed present grievance application before this Forum on 8.2.2013 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as Regulations).

- 2. The applicant's case in brief is that his electric meter is fast. In the month of December 2012, the applicant received bill of Rs. 2410/- and in the month of January 2013 he received bill of Rs. 7880/-. Therefore applicant requested to revise the bill. Applicant filed an application before I.G.R.C. but it was rejected. Therefore this application.
- 3. Non applicant SPANCO denied the applicant's case by filing reply Dt. 2.3.2013. It is submitted that meter of the applicant is O.K. and therefore the application may be dismissed.
- 4. Forum heard the arguments of both the sides and perused the record.
- 5. On 5.3.2013 it is ordered by the Forum that meter be tested in the laboratory in presence of the applicant and Member / Secretary of the Forum and to submit testing report. Accordingly, Dy. Executive Engineer (T) Division, NUZ, Nagpur filed meter testing report on record. This report shows that meter is fast by 18.20%.
- 6. Therefore it is necessary to revise the bill of the applicant since 4.1.2013 according to regulation 15.4.1 of MERC (Electricity Supply Code and Other Conditions of Supply) Regulations 2005.
